The members present were asked if they had any fundraising ideas.

Lynne Perris suggested the Community Matters Token scheme which is run by Waitrose. It was pointed out that the Club is not a charity so this scheme may not be open to us. It was decided to look into this at the next Committee Meeting.

John Devine suggested a Quiz evening. This could be run instead of having a speaker which would save the Club money. The winning team would win a prize. This can be discussed at the next Committee Meeting. This suggestion was made to Mel Hughes and Denise Pattison after the meeting had ended.

**7. Election of the Examiner of the Accounts**

Christine Stephens had agreed to examine the accounts for the coming year and it was agreed that she be appointed. Mel advised the meeting that Christine is to be paid a lower fee this year.
